NOTICE OF PROPOSED REGULATION REPEAL**

REGULATION NUMBER AND TITLE: FPU-3.010 On-Campus Residency Requirement.

SUMMARY OF THE REGULATION: This regulation requires all full-time undergraduate students with less than 30 credit hours to reside on campus and outlines the exceptions for that requirement and is being repealed as it is no longer desired by the University.

THE FULL TEXT OF THE EXISTING REGULATION IS PROVIDED BELOW:

FPU-3.010 On-Campus Residency Requirement.

~~(1) On-Campus Residency.~~ The University requires all full-time undergraduate students entering the University with less than 30 college credits to reside in a housing facility on the University's main campus for their first two semesters of enrollment at the University, subject to space availability.

~~(2) Exceptions.~~ An exemption from the On-Campus Residency requirement may be granted by the President or designee if:

- ~~(a) The student resides at home with his or her parent or legal guardian and the permanent residence is within 30 miles of the main campus;~~
- ~~(b) The student is 21 years old or older by the first day of classes of the student's first term of enrollment;~~
- ~~(c) The student is married;~~
- ~~(d) The student has custody of dependent children; or~~
- ~~(e) The student has a compelling circumstance, provides a letter concisely and fully describing the circumstance, and attaches supporting documentation.~~
